MY LUNCHTIME CHOICES!

Extra Entrée – Extra Milk

All Students, at an extra cost, can purchase an additional entrée or milk offered as part of the school lunch program. For example if a student wants a second entrée, or an additional entrée, like a slice of pizza, then that entrée can be selected in the lunch line and charged to the student's account. Extra entrees are only sold to students who first purchase a school lunch. Again, all students who have purchased a lunch can have extra servings of canned fruit, fresh fruit and fresh vegetables at no charge. If a student receives free or reduced meals they may receive one entrée with their meal but they must have money in their account to purchase any extra entrees.

Snacks

For Middle/High School students, snack items will be available during the lunch period. Snack items offered include: 100% Fruit Juice drinks, a variety of baked chips, yogurt, whole grain muffins, cookies and granola bars. All snacks meet standards set by Kingsley-Pierson Wellness Policy and are USDA Compliant.

Kingsley Pierson 2020-2021 Lunch Account Policy

If you send cash with your child, please place it in a sealed envelope with their name on it and please specify the account the money should be used for. We are not responsible for lost, unidentified, or stolen cash. The program will allow the purchase of one breakfast and one lunch per day at the meal price set for Paid, Reduced, or Free qualifying status.

A Point of Sale (POS) software system is used for the school lunch program. Please note the following important information.

- ◆ Each Student will have an individual account and a family account.
- ◆ Please specify whether money is to be placed in the student's account or the family account
- ◆ Payments will be put towards any negative account balances first, and the account will show a remaining balance.
- ◆ Parents may choose to not allow their children to charge extra lunch entrée items or ala carte items against their account. Please let the school know if this is the case.

Lunch Account Deposits must be made before school starts. Because we receive an overwhelming amount of deposits the morning of the first day of school, we cannot guarantee that we will be able to input all deposits into accounts before the lunch period begins. To insure that your deposit is credited to your student's lunch account on the first day of school, please make a lunch program payment during registration or any time before school starts on August 23rd.

Be sure to include your name and the student's name. Also include any changes in your address or telephone number.

Lunch Account Deposits can also be made online by using the PaySchools system available on the district's website, located at www.k-pcsd.org (click on parent resources and then PaySchools parent access.)

Free & Reduced Meal Applications must be received by Administration AND approved before school starts to be in force for the first day of school. However, we also know how family circumstances may change. Applications will be accepted anytime during the school year for such instances.

Applications can be picked up at the District Administration Building, or are available at the school website on the "Forms" page. Lunch status from last year is carried over for 30 operational days.

Online Lunch and Breakfast Menus!

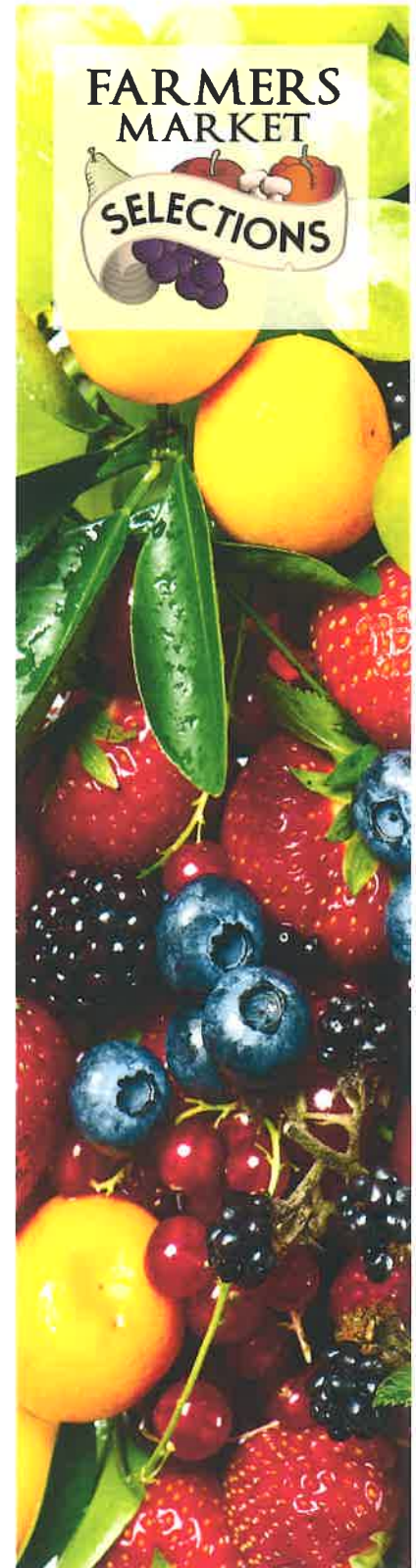
